# Trustees' Annual Report Year ended 31 December 2024

#### **Trustees**

Members of the Kirk Session and the Congregational Board are trustees of the charity, Prestongrange Church. The Members of the Kirk Session are chosen from members of the congregation who are considered to have the appropriate gifts and skills to lead the church. Members of the Kirk Session are elders. Ordination to the eldership is for life, but membership of the Kirk Session need not be. If you wish to resign from the Kirk Session, it must be done in writing to the session clerk who will inform Session at the next meeting. If you do not resign from the Kirk Session, you are still responsible for all the decisions made in the business of Session. The minister, who is a member of the Kirk Session, is selected by the congregation, and inducted by the Presbytery of Lothian. The Clerk to the Kirk Session and the Treasurer are appointed by the Kirk Session.

Members of the Congregational Board are nominated, elected, and appointed at the stated annual meeting of the congregation from the membership of the congregation. The members are chosen as having the commitment and the appropriate skills to manage the financial affairs of the church. Board members serve for two years after which they are eligible for re-election. The Clerk to the Congregational Board is appointed by the Board.

#### 2024

Throughout 2024 we were in Vacancy. The vacancy started in November 2023 after Rev K Donald retired. We had the good fortune of Rev Robin Hill from Longniddry Parish Church as our Interim Moderator and Rev Fred Harrison was our Locum, until November 2024. As well as guiding the Nominating Committee, Robin directed and encouraged me in running all aspects of the church. I can't thank him enough for his inspiration and guidance. Fred made the running of Sunday Worship very easy for me to organize and he conducted funerals and other pastor duties diligently.

The congregation continued with the prayer breakfast, the ladies' Bible study, as well as starting a prayer group to pray for the Nominating Committee. Visiting and phone calls continued to those who couldn't physically attend church services. The Website and Facebook continued to be well managed.

The Church Hall continued to be successful in terms of the number of lets and covering all its financial commitments.

There was a sense of excitement as we, the congregation, watched the nominating committee, knowing that they were seeking God's guidance in searching for a new minister for our church.

On Sunday 29<sup>th</sup> September we were blessed by Rev Eckhardt Bosh, preaching as sole nominee. On Thursday14<sup>th</sup> November, he was inducted as the minister of Prestongrange Church, which we were all delighted with.

The Rev Bosch, brought with him, Rozelle his wife, and his 2-year-old daughter, Lorelei. On January 17<sup>th</sup> a beautiful baby boy, called Lucien, was born, much to the delight of their family and their Church Family. We continue to pray with love for many blessings for the family in 2025 and beyond

Nominating Committee

In December 2023 the congregation of Prestongrange voted for thirteen members to form a Nominating Committee. The purpose of the Nominating Committee was to select a candidate as sole nominee that the congregation would hear and then vote on. The Nominating Committee represented the church with due diligence over the process with the valued guidance of Rev. Robin Hill, Interim Moderator.

The Nominating Committee began their work in January 2024, by August a sole nominee was selected, and arrangements were made for Rev. Bosch to preach at Prestongrange at the end of September.

Throughout the recruitment process we sought the Lord as we read and reflected on God's word, in our individual, and collective prayer times. As a Nominating Committee there was one word that kept coming to us - **trust**.

The book of the Bible that the use Nominating Committee used to help guide them through the ten months of the vacancy was Nehemiah. Nehemiah was in a position of trust, he was the cup bearer to King Artaxerxes. He was in a position of trust because God knew He could trust him. Nehemiah trusted in God as he sought to complete the work of rebuilding the city walls until the task was completed.

Just as the walls in Jerusalem were broken down you may have noticed if you enter Prestonpans from Wallyford that the large wall before the turning to Drumhor caravan park is broken down and in need of repair. There are things in our individual lives and as a church that need repaired, restored and rebuilt. We needed someone with leadership skills, someone like Nehemiah to lead us.

Nehemiah coordinated the efforts of the workers, he inspired their co-operation by setting before them a clear vision. Rev. Bosch shared with the Nominating Committee that his vision for Prestongrange aligns with the vision the elders set out in our Parish Profile, which is to be a church who are "Loving and Sharing Jesus".

Nehemiah commended the workers for their sacrificial efforts, we saw how Rev Bosch recognised the gifts and talents of his congregation at Forth St Paul's. He also commended the effort and thought the Nominating Committee had put into ensuring he felt welcomed at his interview.

Nehemiah was effective at communicating what needed to be done, by whom and when. We are excited to have Rev Bosch lead us as our new minister. We believe that with his leadership skills of co-ordination, co-operation, commendation and communication that we will be enabled to bless the community of Prestonpans as we serve them by "Loving and Serving Jesus".

#### Prayer

Charles Spurgeon is said to have called the prayer meeting the 'engine room' of the church. "If the engine room is out of action", he explained, "then the whole mill will grind to a halt". There were a couple changes to prayer in the life of Prestongrange during 2024.

**Firstly**, there was an opportunity for an informal prayer gathering after Sunday morning worship. The purpose of the gatherings was to seek God's face as we sought His leading and guiding for the prospective applicants, candidates and eventually the sole nominee. The prayer gathering was open to all who attended morning worship each Sunday, it was led by either the locum minister or the Convenor of the Nominating Committee.

Prayer was integral to the work of the nominating committee, all meetings began and ended with prayer. At the outset of the recruitment process the committee set time apart for the sole purpose of prayer and seeking God's face and His will for the task ahead.

The second change in 2024 was that Prayer Breakfast is being held in-person again. There continues to be a small core of three who meet regularly to pray. We meet at 08:30 for a time of reflection, followed by prayer and fellowship over breakfast

It has been a good year for the Ladies Bible Study Home Group meeting on a Tuesday evening at 7.15.

#### Sunday Club Report March 2025

The Sunday Club has grown in number over the past year and we now, regularly, have 8 - 10 children of a variety of ages attending, with six regular volunteers leading the sessions on a rota basis.

We have adapted our sessions throughout the year and currently have a "soft start" for the children as they come into church which is held in the Creche. This allows a gentle introduction to the other children and to those leading the session. The Sunday Club go into church during the second hymn for their talk by the minister and a song. Then the children have a story, sometimes using a video animation, a craft with the appropriate scripture then a song and prayer covering the theme of the lesson. Recently, we have been looking at the Parables and Miracles of Jesus.

The Sunday Club and a selection of volunteers took part in the Nativity play on the Sunday before Christmas. The shortage of children at that time meant a few parts had to be doubled up but the show went on. Thank you to all who took part.

As our numbers increase, we may need to look at using the hall as well as the creche in the future but that has an impact on the number of volunteers needed. If this is something you feel God is nudging you to take part in, then please speak to myself or any of the leaders. It is such a rewarding way to serve the Lord!

Finally, a big thank you to all the volunteers who spend time preparing crafts, leading lessons and supporting the children. It is greatly appreciated!

## Safe Families

"Safe Families is a charity which offers support to children, families and care leavers. This is done primarily, but not exclusively, with and through local churches.

Safe Families is made up of over 5,000 volunteers from over 1,500 churches and community groups across the UK.

A few of the congregation now volunteer to walk alongside families who need assistance. One volunteer is in placement with a young girl and her family. Another helps to support a lone parent with a teenage daughter. This involves giving up a few hours, sometimes weekly,

fortnightly or whatever suits the volunteer, and the family involved. Sometimes this involves meeting within the family's own home or taking the child out for a while.

It is very rewarding working with these young people and their families and to see them grow and progress with Safe Families help."

### **Financial Review**

The principal source of income is from weekly offerings and member's payments into the bank. Gift aid was claimed during the year and added a further £6,151 to church funds. Where appropriate we encourage the use of Gift Aid.

No funds from the church were gifted to other charities in 2024. Church members contributed £373 to local charities in 2024.

With the additional purchase of a new Manse, we took the opportunity to add new items in preparation for the new minister. There were also additional preparation costs. These were part funded by drawing  $\pounds5,503$  from the Capital Account. In addition to this,  $\pounds5,000$  was withdrawn from the Revenue Account to help with insurance and utility costs. Both Manses were vacant for a spell, during which the church paid for the utilities.

### Reserves Policy

It is the trustees' policy to ensure that all commitments are met each year. Where possible, a surplus is carried forward to meet expenses early in the following year, during a season when money is slow to come in. At the end of the year, the congregation held unrestricted cash funds of £12,019 which is less than the previous year. The Kirk Session and Board decision in 2023 to set aside £10,000 for the start-up fund for taking on a Youth and Children's worker has been postponed until the new minister is in post.

## Statement of Trustees' Responsibilities

The members of the Kirk Session and the Congregational Board must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the church during the financial year. The same members are responsible for keeping proper accounting records, available on request, which must reflect the financial position of the church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustees Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006, and the Regulations and Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. The same members are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and detection of fraud and other irregularities.
